**APPLICATION :**

They are suitable for use in food industries (high resistance to animal greases and blood).

Working temperature : 85°C - Does not harden

**APPLICATION :**

Fishmonger's shop, oyster farming, hospital, dishwashing, chemical industries, dairies, cheese dairies, red meat, poultry...

**WASH :**

The apron should be washed with soapsuds at 80°C or in a mixture of water and soft detergent and rinsed with cleared water. Do not use toxic to wash or rinse.

The apron must be hung up to dry, without being wringed and stored dry, away from light in a dry and ventilated place.

The apron must be replaced as soon as you notice wear signs on it.

**STANDARDS :**

- Apron compliant with EU regulation No. 10/2011 concerning plastic materials and objects intended to come into contact with foodstuffs. This PPE can be brought into incidental contact with all types of foodstuffs with the exception of acidic foodstuffs (pH less than 4.5)
- Apron compliant with Article 33 of REACH Regulation No. 1907/2006 concerning products containing substances of very high concern; Does not contain phthalate, silicone (and silicone derivatives), or bisphenols.
- Complies with REGULATION (EU) 2016/425 relating to personal protective equipment (category I)
- Complies with European standards:
  - \* NF EN 13688:2013 Protective clothing general requirements
  - \* Mechanical properties claimed: resistance to abrasion, tearing, traction and perforation.

**STANDARD**

Adjustable strap around the neck closure in the back with a hook and an elastic band

**HARNESS**

Straps over the shoulders with adjustment buckles for a better comfort, closure in the back with a hook and an elastic band

**AUTOMATIC**

Straps over the shoulders, the closure is made by tying up the apron in the back
